**PLAINTIFFS' ORIGINAL PETITION**

TO THE HONORABLE JUDGE OF SAID COURT:

The State of Texas; the Cities of Plainview, Lubbock, Amarillo, Lamesa, Floydada, and Snyder, Texas; and the Counties of Hale, Lubbock, Dawson, and Scurry, Texas (“Plaintiffs”), acting through the Office of the Attorney General of Texas (“Attorney General”), complain of Defendants Bart Wade Reagor and Franklin Rick Dykes (collectively “Defendants”), on the following grounds:

**I. Service and Jurisdiction**

1. Plaintiffs allege that discovery is intended to be conducted under Level 2 of Rule 190 of the Texas Rules of Civil Procedure.
2. Bart Wade Reagor is an individual who can be served with process at 2809 19th Street, Lubbock, Texas 79410-1504.
3. Franklin Rick Dykes is an individual who can be served with process at 2106 Vicksburg Avenue, Lubbock, Texas 79407-2244.
4. Venue and jurisdiction of this suit are exclusively conferred upon this Court pursuant to Section 111.010 of the Texas Tax Code (the “Tax Code”). The above-named local taxing authorities have authorized the Attorney General to join them as Plaintiffs to this suit.
5. The amounts sought to be recovered in this suit are within the jurisdictional limits of this Court. Plaintiffs seek monetary relief of \$100,000 or less, including damages of any kind, penalties, costs, expenses, pre-judgment interest, and attorney fees.

**II. Cause of Action Against Defendants for Sales and Use Tax Originally Incurred by Reagor Dykes Auto Company, LP**

6. Under the provisions of the Tax Code, Bart Wade Reagor and Franklin Rick Dykes became obligated to pay sales and use tax, interest, and penalties to Plaintiffs for the periods and in the amounts shown on the certificate of the Comptroller of Public Accounts for the State of

Texas (“Comptroller”) attached as Exhibit A, plus additional interest at the statutory rate established by Section 111.060 of the Tax Code on the amount of delinquent sales and use tax included in Exhibit A from the date specified in Exhibit A until the date of final judgment. This certified amount remains due and unpaid despite demand for payment. Pursuant to Section 111.016 of the Tax Code, Defendants are liable as responsible individuals of Reagor Dykes Auto Company, LP<sup>1</sup> for trust fund sales and use tax collected but not remitted and for penalty and interest thereon. All conditions precedent to Plaintiffs’ recovery have been performed or have occurred.

**III. Cause of Action Against Defendants for Sales and Use Tax Originally Incurred by Reagor-Dykes Plainview, LP**

7. Under the provisions of the Tax Code, Bart Wade Reagor and Franklin Rick Dykes became obligated to pay sales and use tax, interest, and penalties to Plaintiffs for the periods and in the amounts shown on the certificate of the Comptroller of Public Accounts for the State of Texas (“Comptroller”) attached as Exhibit B, plus additional interest at the statutory rate established by Section 111.060 of the Tax Code on the amount of delinquent sales and use tax included in Exhibit B from the date specified in Exhibit B until the date of final judgment. This certified amount remains due and unpaid despite demand for payment. Pursuant to Section 111.016 of the Tax Code, Defendants are liable as responsible individuals of Reagor-Dykes Plainview, LP<sup>2</sup> for trust fund sales and use tax collected but not remitted and for penalty and interest thereon. All conditions precedent to Plaintiffs’ recovery have been performed or have occurred.

**IV. Cause of Action Against Defendants for Sales and Use Tax Originally Incurred by Reagor-Dykes Imports, LP**

8. Under the provisions of the Tax Code, Bart Wade Reagor and Franklin Rick Dykes became obligated to pay sales and use tax, interest, and penalties to Plaintiffs for the periods and

This certified amount remains due and unpaid despite demand for payment. Pursuant to Section 111.016 of the Tax Code, Defendants are liable as responsible individuals of Reagor-Dykes Imports, LP<sup>3</sup> for trust fund sales and use tax collected but not remitted and for penalty and interest thereon. All conditions precedent to Plaintiffs’ recovery have been performed or have occurred.

**V. Cause of Action Against Defendants for Sales and Use Tax Originally Incurred by Reagor-Dykes Amarillo, LP**

9. Under the provisions of the Tax Code, Bart Wade Reagor and Franklin Rick Dykes became obligated to pay sales and use tax, interest, and penalties to Plaintiffs for the periods and in the amounts shown on the certificate of the Comptroller of Public Accounts for the State of Texas (“Comptroller”) attached as Exhibit D, plus additional interest at the statutory rate established by Section 111.060 of the Tax Code on the amount of delinquent sales and use tax included in Exhibit D from the date specified in Exhibit D until the date of final judgment. This certified amount remains due and unpaid despite demand for payment. Pursuant to Section 111.016 of the Tax Code, Defendants are liable as responsible individuals of Reagor-Dykes Amarillo, LP<sup>4</sup> for trust fund sales and use tax collected but not remitted and for penalty and interest thereon. All conditions precedent to Plaintiffs’ recovery have been performed or have occurred.

**VI. Cause of Action Against Defendants for Sales and Use Tax Originally Incurred by Reagor-Dykes Motors, LP**

10. Under the provisions of the Tax Code, Bart Wade Reagor and Franklin Rick Dykes became obligated to pay sales and use tax, interest, and penalties to Plaintiffs for the periods and in the amounts shown on the certificate of the Comptroller of Public Accounts for the State of

Under the provisions of the Tax Code, Bart Wade Reagor and Franklin Rick Dykes became obligated to pay sales and use tax, interest, and penalties to Plaintiffs for the periods and in the amounts shown on the certificate of the Comptroller of Public Accounts for the State of Texas (“Comptroller”) attached as Exhibit F, plus additional interest at the statutory rate established by Section 111.060 of the Tax Code on the amount of delinquent sales and use tax included in Exhibit F from the date specified in Exhibit F until the date of final judgment. This certified amount remains due and unpaid despite demand for payment. Pursuant to Section 111.016 of the Tax Code, Defendants are liable as responsible individuals of Reagor-Dykes Floydada, LP<sup>6</sup> for trust fund sales and use tax collected but not remitted and for penalty and interest thereon. All conditions precedent to Plaintiffs’ recovery have been performed or have occurred.

**VIII. Cause of Action Against Defendants for Sales and Use Tax Originally Incurred by Reagor Auto Mall, Ltd.**

12. Under the provisions of the Tax Code, Bart Wade Reagor and Franklin Rick Dykes became obligated to pay sales and use tax, interest, and penalties to Plaintiffs for the periods and in the amounts shown on the certificate of the Comptroller of Public Accounts for the State of

Pursuant to Section 111.016 of the Tax Code, Defendants are liable as responsible individuals of Reagor Auto Mall, Ltd.<sup>7</sup> for trust fund sales and use tax collected but not remitted and for penalty and interest thereon. All conditions precedent to Plaintiffs’ recovery have been performed or have occurred.

**IX. Cause of Action Against Defendants for Sales and Use Tax Originally Incurred by Reagor-Dykes Snyder, LP**

13. Under the provisions of the Tax Code, Bart Wade Reagor and Franklin Rick Dykes became obligated to pay sales and use tax, interest, and penalties to Plaintiffs for the periods and in the amounts shown on the certificate of the Comptroller of Public Accounts for the State of Texas (“Comptroller”) attached as Exhibit H, plus additional interest at the statutory rate established by Section 111.060 of the Tax Code on the amount of delinquent sales and use tax included in Exhibit H from the date specified in Exhibit H until the date of final judgment. This certified amount remains due and unpaid despite demand for payment. Pursuant to Section 111.016 of the Tax Code, Defendants are liable as responsible individuals of Reagor-Dykes Snyder, LP<sup>8</sup> for trust fund sales and use tax collected but not remitted and for penalty and interest thereon. All conditions precedent to Plaintiffs’ recovery have been performed or have occurred.

**X. Attorney Fees**

14. In accordance with Section 2107.006 of the Texas Government Code, the Attorney General is entitled to recover reasonable attorney fees, investigative costs, and court costs on behalf of Plaintiff the State of Texas.
